ORDER

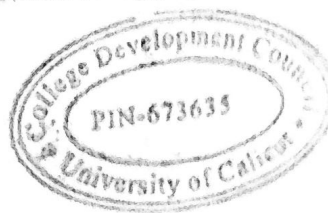
1. Provisional affiliation was granted for starting B. Ed. degree programme in Holy Family College of Education for Women (Un-Aided), Koduvayoor, Palakkad during the academic year 1995-'96 with an intake of 100 students, vide U.O. read as (1). The optional subject Natural Science was added in the B.Ed. programme with an intake of 16 students without change in total intake, vide U.O. read as (2).
2. As per the National Council for Teacher Education (NCTE) Regulations 2014, vide paper read as (3) above, B. Ed. programme shall be of having a duration of two academic years, and the intake shall be with a basic unit of 50 students with a maximum of two units. The NCTE permitted the college for conducting B.Ed. programme of two years duration with an annual intake of 100, for two basic units of 50 students each from the academic session 2015-'16, vide paper read as (4).
3. As per U.O. read as (5) above, the Syndicate resolved to grant Continuation of Provisional Affiliation to Teacher Education Colleges as usual in the beginning of the academic year as in the case of other programmes, without insisting extension of the approval from NCTE.
4. A revised seat distribution in B.Ed. programme w.e.f. the academic year 2020-'21 was sanctioned along with re-arrangement of seats for the academic year 2020-'21 in the College, vide U.O. read as (6) above.
5. Continuation of Provisional Affiliation was granted to B.Ed. programme in the College for the academic year 2022-'23, vide U.O. read as (7).
6. The Principal, Holy Family College of Education for Women (Un-Aided), Koduvayoor, Palakkad has submitted application for Continuation of Provisional Affiliation to the self financing B. Ed. programme for the academic year 2023-'24, vide paper read as (10) without renewed NOC from Govt. of Kerala for the academic year 2023-'24 which is mandatory for granting continuation of provisional affiliation to all self-financing programmes in Aided and Un-Aided colleges, except those under the management of IHRD and LBS, as per U.O. read as (8).

7. Considering the matter in detail, sanction has been accorded by the Vice Chancellor to grant Continuation of Provisional Affiliation to the self financing B.Ed. programme in Holy Family College of Education for Women (Un-Aided), Koduvayoor, Palakkad for the academic year 2023-'24 conditionally, subject to submission of renewed NOC from Govt. of Kerala for the academic year 2023-'24, as detailed below:

8. Orders are issued accordingly subject to the following terms and conditions:

- The Principal is strictly directed to engage faculties with qualifications prescribed by NCTE and in compliance with the provisions of the Kerala Self Financing College Teaching and Non-Teaching Employees (Appointment and Conditions of Service) Act 2021 (ACT 13 of 2021).
- Affiliation granted is strictly provisional and only for the academic year 2023-'24. The College has to apply for Continuation of Provisional Affiliation for the ensuing academic years by remitting the fee fixed by the University.
- The management should abide by the provisions of the University Act, Statutes and Regulations of the University with regard to admission of students, collection of fee etc.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- Conducting University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- Pareeksha Bhavan shall ensure that examinations are conducted only in those colleges which have valid affiliation orders.
- In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form.
